Position Summary:

The Transportation Driver will primarily be responsible providing safe, reliable, and courteous transportation to clients in East Harlem and surrounding areas.

Responsibilities:

- Operate and maintain an assigned passenger vehicle and provide transportation to clients on a daily basis. Ensure clients are following proper safety procedures (wearing a seatbelt, no smoking, etc.).
- Assist each client in and out of the vehicle, with special attention to handicapped clients;
 operate wheel chair lift as necessary.
- Follow daily schedule for trips and events, as provided.
- Perform daily pre-trip and post-trip inspection of assigned vehicle. Inform supervisor of daily activity and/or vehicle issues at the end of each scheduled work shift.
- Perform general maintenance on vehicle (cleaning interior and exterior, fueling), and take vehicle for scheduled maintenance and inspections.
- Follow agency protocol and procedure for client sign-in and contributions.
- Complete Daily Trip Report paperwork.
- Prepare accident and incident reports, as necessary.
- Become familiar with and follow all Transportation Program guidelines, policies and procedures including but not limited to: Guidelines for Program Eligibility, Emergency Plan, Safety, Emergency/Accident and Disaster Response Procedures, Grievance Complaint Procedure, Individual and Group Trip Guidelines.
- Assist with other program duties as assigned by the Transportation Coordinator, the Deputy Director of Senior Services, or the Director of Senior Services.

Qualifications:

- High school diploma or GED.
- Valid license to operate a vehicle in New York State.
- At minimum three years experience operating a vehicle.
- No convictions for driving while intoxicated in the prior 2 years.
- No more than one moving violation within the prior 2 years.
- Strong English speaking and writing proficiency; Bilingual (English/Spanish) a plus.
- Physical ability to assist clients in and out of vehicles.
- Good organizational ability, time management, and interpersonal skills (ability to connect with clients and work with a team).
- Knowledge of and desire to work with aging populations.
