Position: Leadership Development Counselor Advocate

Department: Youth Services

Reports to: Union East Program Coordinator **Hours:** Part-Time, 25 hours per week

Overall Responsibilities: Management and maintenance of 30 participants and weekly leadership development activities and workshops to approximately 75 participants.

General Responsibilities:

- Recruitment of participants and facilitation of intake.
- Development of an Individual Service Strategy (ISS) for each participant.
- Attendance Improvement Dropout Prevention services including home visits as needed.
- Quarterly review of each ISS.
- Identification and review of educational and occupational needs of each participant leading to a schedule of activities.
- Administration of face-to-face advisory sessions, "One-to-One Meetings", at least once every twenty (20) days with each participant.
- Maintenance of weekly contact including conducting phone calls and attending program activities with each participant.
- Administration of group meetings, including but not limited to study groups and workshops.
- Development and implementation of elective activities for general program membership.
- Weekly recording of case notes for each participant.
- Thorough completion and timely submission of all forms including, but not limited to weekly reports; stipend allocation, grievance, complaint, referral forms; and incident reports.
- Weekly review of caseload with supervisor.
- Collection of documentation from participants, including but not limited to: eligibility documentation, report cards, pay stubs, college admissions information, etc.
- Facilitation of weekly leadership development workshops and activities to 75 students.
- Participate on at least one Youth Services programmatic committee
- Fulfillment of other responsibilities as assigned by the Program Coordinator, Assistant Director of Youth Services, and Director of Youth Services

Qualifications:

- Bachelor's Degree in Education, Sociology, Psychology or related field preferred; at minimum, an Associate's Degree with a minimum three years experience working in a youth services program, specifically disadvantage youth.
- Bilingual (English/Spanish) preferred.
- Strong verbal, written, administrative, organizational, and problem solving skills.
- Proficiency in Microsoft Word, Excel, and Publisher preferred.
- Demonstrated ability to perform multiple tasks effectively in a fast-paced, challenging, and constantly changing environment.
- The ability to perform at a high level.
- Dedication to serving youth in an urban setting.
- Innovation and patience.
- Demonstrated understanding of the challenges facing youth in an urban setting.
