Joy Pittman most recently served as the Human Resources Manager for the Start Treatment and Recovery Centers, and before that was the Assistant to the Provost at Long Island Business Institute, where she managed the college's human resources operations. She has had a distinguished career overseeing and implementing strategic human resources functions, including talent acquisition and development, and she still serves as an Adjunct Professor at Long Island Business Institute. Ms. Pittman holds a Bachelor's Degree in Economics from the City College of New York, a Master's Certificate in Strategic HR Management from Cornell University and certifications as a Senior Human Resource Professional (SPHR and SHRM-SCP).
