Ms. Estades is an active member of the East Harlem community, and currently volunteers with the East Harlem Community Health Committee, Cielo Arts and the Latino Leadership Institute. She holds a BA from Middlebury College, an MS in Nonprofit Management from the New School, and a JD from Rutgers University. "Union Settlement has a long and distinguished history of providing critically needed community-based services to our community," said Ms. Estades.
